

MAY 2025 - RETAKE OPTIONS

The 2025 exams will test tax law enacted up to 31 July 2024 which includes both Finance Act 2024 and Finance (No 2) Act 2024 – where we simply refer to the updated materials as “FA24”, they have been updated for both Finance Acts. All ATT materials reflect the new exam structure/format.
